SUB-SERIES

CITY=City of Davenport vs. Individual or Company

Handled by Police Magistrate

Contents: defendant's name, date, ordinance violated, whom warrant was issued and served by, plea, fine or jail sentence, fees

Offenses included: keeping a disorderly house, failure to stop, improper parking, parking auto without both right wheels facing curb, resisting police officer, disturbing the peace-public or private, overtime parking, permitting horses to run at large, exceeding speed limit, leading an immoral life, reckless driving

CIVIL=Individual vs. Individual or Company

Handled by Justice of the Peace

Contents: Parties involved, date, issue at hand, changes or venue, outcomes

Offenses included: equity cases, automobile damages, loans

CRIMINAL=State of Iowa vs. Individual

Handled by Justice of the Peace

Contents: defendant, date, charge, warrants, lawyers, witnesses, if testimony heard, outcome=judgment or case dismissed

Offenses included: murder, forgery, fraud, embezzlement, larceny, assault and battery, crime of seduction, being a tramp, intoxication, operating a motor vehicle while under the influence, illegal transportation of intoxicating liquor, false drawing of check
